

GENERAL TERMS AND CONDITIONS | LA BODEGUITA

Article 1 | Definitions

- 1.1. **La Bodeguita:** La Bodeguita Dance School, located in The Hague.
- 1.2. **Participant:** The person who enrolls for classes or workshops at La Bodeguita.
- 1.3. **Strip Card:** A prepaid card for a certain number of classes (10, 20, or 30).
- 1.4. **Subscription:** An ongoing agreement for attending classes over a specified period.

Article 2 | Applicability

- 2.1. These terms and conditions apply to all classes, workshops, and events of La Bodeguita.
- 2.2. Deviations from these terms can only be made in writing.

Article 3 | Strip Cards

- 3.1. Strip cards are personal and non-transferable.
- 3.2. Available cards: 10, 20, or 30 classes.
- 3.3. Validity of strip cards:
 - 10 classes: 3 months
 - 20 classes: 6 months
 - 30 classes: 12 months
- 3.4. No refunds for expired or unused classes.

Article 4 | Subscriptions

4.1. Subscriptions are available for 3, 6, or 12 months.

4.2. After the contract period, the subscription is automatically renewed on a monthly basis unless canceled.

4.3. Subscription pause:

- 3 months: maximum 7 days pause
- 6 months: maximum 14 days pause
- 12 months: maximum 30 days pause

4.4. A pause must be requested at least 1 week in advance via info@labodeguita.nl.

Article 5 | Payment and Cancellation

5.1. Subscriptions and strip cards must be paid in advance.

5.2. Cancellation of subscriptions must be done at least 1 month in advance via email to info@labodeguita.nl.

5.3. No refunds for missed classes, unless La Bodeguita cancels the class.

Article 6 | Photos and Videos

6.1. Photos and videos may be taken during classes and events.

6.2. By participating, you consent to these images being used for promotion on our website or social media.

6.3. If you do not wish to be filmed or photographed, please inform the photographer or videographer before the class or event, or notify us in advance via info@labodeguita.nl.

Article 7 | Liability

7.1. Participation in classes is at your own risk.

7.2. La Bodeguita is not liable for injuries or damage to personal property, unless caused by intent or gross negligence.

Article 8 | Privacy and Data Protection

8.1. We respect your privacy and handle personal data in accordance with the General Data Protection Regulation (GDPR).

8.2. Data is only used to perform our services and is never shared with third parties without consent, unless legally required.

Article 9 | Complaints and Disputes

9.1. Complaints can be reported within 14 days via info@labodeguita.nl. We will work together to find a solution.

9.2. Unresolvable disputes may be submitted to the competent court in The Hague.

Article 10 | Changes to the General Terms and Conditions

10.1. La Bodeguita may amend these terms. Changes will be announced at least 30 days in advance via email or our website.

10.2. If you object to the changes, you can terminate the agreement.

Article 11 | Force Majeure

11.1. La Bodeguita is not liable for situations beyond our control, such as extreme weather conditions or technical failures, which may prevent classes from taking place.

Article 12 | Membership Upgrades and Downgrades

12.1. Downgrading the subscription is not possible during the contract period.

12.2. Upgrading the subscription is possible, with the benefits of the new level taking effect immediately.

Article 13 | Making Up Missed Classes

13.1. Missed classes may be made up within a period of one month, provided the subscription is still active.

13.2. This option is not available after canceling the subscription.
